


Mission Vision

UNDRIP Article 14

Indigenous peoples **have the right** to establish and control their educational systems and institutions providing education in their own languages, in a manner appropriate to their cultural methods of teaching and learning.

Indigenous individuals, particularly children, have the right to all levels and forms of education of the State without discrimination.

States shall, in conjunction with indigenous peoples, take effective measures, in order for indigenous individuals, particularly children, including those living outside their communities, to have access, when possible, to an education in their own culture and provided in their own language.


Swift Action

The perilous state of most First Nation languages makes the need for the implementation of Article 14 pressing and urgent.

Inaction means continued forced assimilation.

 Children are required by law to attend school to learn in English and French






Defined and Enforceable Rights

If the *Indigenous Languages Act* was amended to incorporate and enact Article 14 of the Declaration. Indigenous peoples would then, like official language minorities, possess the **defined right** to educate their children in their own languages at publicly funded schools and the **legal remedies to enforce** that right.





Intergenerational Transmission

Requires state-supported educational systems and institutions that:

- teach First Nation children their own ancestral languages; and,
- teach other subjects in those languages.

Article 14 recognizes that such systems must exist both on and off reserve
