#### **History of the NEWG**

- AFN Resolution 39/2016, *First Nations National Working Group on Early Learning and Child Care (ELCC)*, established the National Expert Working Group (NEWG) on First Nations ELCC to lead engagement with First Nations to develop a First Nations ELCC Framework.
- NEWG Membership:
  - Co-chaired by AFN and Employment and Social Development Canada (ESDC)
  - Representatives from each AFN region
  - Representatives from Indigenous Skills, Employment and Training Strategy (ISETS)
  - Representatives from AFN Health and Languages & Learning Sectors
  - Representatives from Indigenous Services Canada and Public Health Agency of Canada



### **National First Nations ELCC Policy Framework**



**Vision:** Happy and healthy First Nations children and families are supported by a regionally-driven ELCC system rooted in Indigenous languages and cultures, governed by First Nations.

### **NEWG's Recent Work & Advocacy**

- Pursuant to AFN Resolution 08/2022, Early Learning and Child Care Legislation, the AFN and NEWG made a submission to the Standing Committee on Human Resources, Skills and Social Development and the Status of Persons with Disabilities in March 2023, focused on:
  - Canada's obligations and commitments to upholding First Nations rights, including obtaining free, prior and informed consent, and providing funding for First Nations-led engagement.
  - Affirming First Nations jurisdiction by acknowledging the inherent rights to selfdetermination and jurisdiction of First Nations to care for their children.
  - Funding for First Nations ELCC, including statutory funding to ensure long-term, sustainable and predictable funding for First Nations ELCC that is distinctions-based, Treaty-based and needs-based.

## **NEWG's Recent Work & Advocacy**

- In accordance with several AFN resolutions regarding the funding allocation model, including AFN Resolutions 59/2018, 64/2019, 20/2020 and 05/2021, the AFN has retained the Institute of Fiscal Studies and Democracy (IFSD) to lead research with First Nations to develop a First Nations-specific funding model for ELCC.
- Timeline:
  - April May 2023: Research underway
  - June August 2023: Continued research, discussions with NEWG and regions towards the development of recommendations for NEWG consideration
  - September December 2023: Engagement in regions on recommendation
  - **December 2023:** Return to First Nations-in-Assembly for approval of recommendation



#### **Next Steps**

- Co-development of a results and evaluation framework for First Nations ELCC with ESDC and the NEWG.
- Continued work towards a First Nations-determined ELCC funding model.
- Continued advocacy for First Nations rights and self-determination as Bill C-35 continues in the legislative process.
