



Benefits of the AES









Culturally appropriate Anishinaabe education Full control of Anishinabek education The Government of Canada has no authority over the Anishinabek Education System The fiscal transfer is grant funding. First Nations have full authority to determine priorities and expenditure of education funds Increased student success



Benefits of the AES



No changes to the ANEA or funding levels unless agreed to by the First Nations



Annual price and volume adjustors



Federal investments in education included in selfgovernment Transfer Payment (General Funding Increase)



May request additional funding for extraordinary circumstances, new programs and additional parties



Own Source Revenue is not a factor in determining Education Transfer Payments



New funding investments from the Province of Ontario

The Double Bilateral Approach







Negotiated the Anishinabek Nation Education Agreement with Canada on a bilateral basis Negotiated a Master Education Agreement with Ontario on a bilateral basis Tripartite meetings with the Anishinabek Education System, Canada and Ontario



Anishinabek Nation Education Agreement

Recognition of First Nation law-making power and other authority over primary, elementary and secondary education

The priority of First Nation education laws

Recognition of the Anishinabek Education System established and operated under Anishinabek Education Law

First Nations continue to administer the Post-Secondary Funding Program

Education Fiscal Transfer Agreement



A 5-year contract that replaced previous funding contracts



Funding that is subject to increases for price and volume



First Nations are eligible for any General Funding Increases in education provided by Canada



Negotiations currently underway for next fiscal transfer agreement



Master Education Agreement

Creates a new partnership between the First Nations and Ontario to support Anishinabek student success in First Nation Schools and provincially-funded schools

Includes a Multi-Year Action Plan, Transfer Payment Agreement and a Data and Information Sharing Agreement

Successes and Opportunities in Self-Governance

- Development of tools and resources that address Anishinabek education priorities
 - Cultural Competency Program
 - AES Wellness Portal
 - Special Education Guideline
 - Student Transitions Protocol
 - Education Services Agreements Guideline and Template
 - Reporting Racism Tool

- Education Major Capital Needs Based Assessment
- Dedicated funding to support governance activities and capacity building
- Regional collaboration and information-sharing



Niigaan Gdizhaami Fund Projects

- More than 120 community projects funded since 2018-2019
 - Funding Streams:

•

- First Nation only
- First Nation with School Board
- First Nation and Other Organization

The projects fund student support positions, language and culture programs, land-based learning activities, cultural events, education programming, reach ahead credits, etc.



Addressing Youth Education Priorities

- Priorities identified by Anishinabek youth at the Niigaan Gdizhaami Forum each year
- First Nations and District School Boards work with youth to develop a plan to address those priorities
- Spring and Fall REC meetings to discuss implementation of the plan
- Report back to youth at next annual forum



Niigaan Gdizhaami Forum and Regional Meetings

- Annual Niigaan Gdizhaami Forum focusses on networking, consultation, relationship building, and establishing priorities
- Anishinabek youth participate with representatives from the 23 Participating First Nations, the Ministry of Education and Ontario District School Boards
- Regional meetings held every Spring and Fall that bring together First Nations and District School Boards to discuss education priorities and establish collaborative action
